

How to make Commonwealth Bank of Australia (and Colonial First State) a trusted developer on your smartphone

Android


While trying to install the app, you may see the following message:



For your security, your phone is not allowed to install unknown apps from this source.

CANCEL SETTINGS

To make Commonwealth Bank of Australia (and Colonial First State) a trusted developer, tap "Settings" on the alert. You'll be redirected to the following page. Toggle "Allow from this source" to ON.



You will then receive an alert asking to install the FirstTech App. Select 'INSTALL'.

Important note: To keep you device secure, once the FirstTech app is installed, toggle OFF the "Allow from this source" setting from the previous step.

iOS

Settings > General > VPN & Device Management > Select Commonwealth Bank of Australia > Tap 'Trust'
