Acadian utilises a systematic multi-factor investment approach, while integrating a range of ESG criteria, to select stocks. This includes having no exposure to stocks that derive any revenue from the production or manufacturing of tobacco and controversial weapons or more than 10% of gross revenue from the production or manufacture of products in alcohol, gambling and adult entertainment; derive more than 20% of gross revenue from thermal coal mining or extraction of unconventional oil & gas.



Performance chart (\$10,000 invested since inception)








